# III. DATES FOR 2008 SENIOR TRIALS

After discussion, the committee voted to revert to starting on Monday, June 16, subject to hotel availability. The date will be announced on the usbf website as soon as we hear from the hotel, and all attendees at this meeting will also receive an email.

#### IV. 2009 CONDITIONS OF CONTEST

The committee discussed the complexities involved when there is a Trials to pick two teams. There was general agreement that the USA2 bracket should include the losers from the first KO round but not teams eliminated in the Round Robin, and that the losing USA1 finalist should have to win only one more match in order to be USA2. The committee was willing for the losing USA1 finalist to have one day off before playing the USA2 finals. # V. 2008 CONDITIONS OF CONTEST

The committee discussed the specific formats for entries of 6-12 teams and agreed on the following:

**6 teams** - Two days of Round Robin play - each day to consist of 5 matches scored at VPs (length of matches wasn't decided, 10, 11, or 12 boards). The VPs from the two days will be added together to get the team's total score. Top 4 teams advance to KO.

7 teams - Same as 6 teams except for match length

8 teams - KO

**9 teams** - 2 days of Round Robin play - each day to consist of 7 matches, 7 boards in each match, with each team getting a bye each day.

10-12 teams - 1 day Round Robin to cut to 8 teams

#### In all Round Robins:

 Teams will submit their lineups in advance. In a one-day Round Robin lineup submission shall be "blind" (don't know which team you are playing against in which match. In the 2 day situation where there are 2 separate matches, each player on each team must play one of the two matches against each other team, but there will be no seating rights - lineups are still submitted in advance. day Round Robins, the schedule of which team you play when will be reversed on day 2.

- · Matches will be played in clumps of a reasonable length
- In the last clump of matches, teams in the Closed Room will be sequestered and there will be no score comparison.
