

## USBC/USWBC ROUND ROBIN SCORING from Jan Martel

Scoring for the Round Robin in the USBC and USWBC this year will be done by the program on our website, based on score sheets that the North player completes at each table. For those of you who played in the USBC last year, the score sheets will look about the same as they did then. However, there is a significant difference this year - these are now official score sheets and must be turned in before you can start your next match. Although you will have an opportunity to correct an incorrect score later, it will be much easier for everyone if you are initially accurate. Please check the results with your opponents at the end of each match before turning in the score sheet.
After each round, the scores on the score sheets will be entered into the computer and the computer will calculate IMPs on each board and VPs for the match. These results will be posted online and in addition we will print a scorecard from the match for each team. The VP results will be entered on a cross-table (two for USBC Round Robin 1 which will have two divisions) on the USBF website. We will have computers with overhead projectors in the lobby areas of both the Open and Closed rooms that will project these cross tables on the wall.

If you disagree with a posted result, you must find the captain of the opposing team and the two of you must submit a score correction to one of the DICs, within one hour after the session in which the match was played.

## USBC Round Robin Lineup Submission Procedure

This year, as for the last few years, we will be using a "blind" lineup submission procedure for the USBC Round Robin. This means that you will not know you opponents for a match until after you have submitted your lineup. Before each "clump" of matches, you will hand your lineup in to one of our logistics staff (Jan, Rena, Jeff or Tom) and he or she will give you your guide cards for the matches in that clump.

With the exception of the final clump of 4 matches in RR2, you may change your lineup between matches of a clump in either the Open of Closed Room. During the final clump of 4 matches in RR2, the Closed Room teams will be sequestered and may not talk to their teammates. No substitutions will be allowed in the Closed Room during those matches. You may make substitutions in the Open Room at any time. Note that the substitutions must be included on the lineup you submit for each clump. You may make substitutions during a match or clump only for emergencies and with permission from a DIC.

## USBC FORMAT AND MISCELLANEOUS INFORMATION

The ITT Conditions of Contest Committee has approved the following format for the USBC Round Robin: The 22 teams playing in the Round Robin will be divided into two 11 team groups of roughly equal ability. Each team will play a 7 board match against each other team in its group. These matches will be played on June 1 st and 2nd. The IMPs in each match will be converted to VP's using the USBF 7-Board VP Scale. At the conclusion of this RR, the bottom 3 teams from each group will be eliminated. The remaining 8 teams from each group ( 16 in all) will complete RR play. Each continuing team will play a 7 board match against each continuing team from the other group, on the second half of Saturday, June 2nd, and the first half of Sunday, June 3rd.

After completion of play, each of the continuing teams will have played a 7 board match against all other continuing teams. In addition, each of the continuing teams will have played 3 matches against eliminated teams. The continuing teams' final scores will be the full VPs earned against other continuing teams, whether those VPs were earned in the first day and a half of play or in the final day of play, plus a percentage of the VPs they earned against the eliminated teams. That percentage will depend on the scores of the eliminated teams - VPs earned against a team that did better will count more. The Round of 16 will start the afternoon of Sunday, $6 / 3$, and take $11 / 2$ days. Each of the Quarterfinals, SemiFinals and Finals will take two days. See the tournament schedule on page 10 for exact times of each session of play.

Ralph led the spade 8 (!), hoping to reach partner for a diamond through. That almost worked, but Justin ruffed, led a trump, and guessed to put in the 8. Then he led a diamond to his 10 and could not be prevented from reaching his hand twice more to finesse hearts. Making for +550 .

In the same contract at another table declarer also guessed trumps, but he tried the diamond jack from dummy. North, Bob Hamman, DUCKED, killing a crucial entry and beating the contract. At a third table, where Kit Woolsey was North, he SPLIT his club honors on the first round. On a technical basis this complicated declarer's task by giving him an extra finesse to take (declarer can still succeed with well-timed play), but the psychological effect of the split worked faster. Declarer couldn't believe that anyone would split from that holding, so he went wrong in trumps and went down.

At other tables South declared 4^, usually doubled. On any lead declarer can make by drawing trumps, taking a diamond finesse, stripping diamonds, and endplaying East in clubs. This line requires West to hold the diamond king and East to hold the heart ace and both top clubs. Even with an opening club lead, declarer can strip spades and diamonds while ruffing one club in hand, then discard a heart on the third club to pickle East. However, at one table declarer stripped both minors and attempted to endplay East by leading a heart toward dummy. West, John Diamond, alertly put up the 9 to scuttle the contract.

## Updated Security Procedures from Jan Martel and Gary Blaiss

Although the provisions of Section XV of the General Conditions of Contest dealing with security issues have not changed, we will be enforcing the provisions more aggressively this year in two areas: electronic devices and kibitzing.

With regard to electronic devices, the rules are as they were in the last few years: No one may have any cell phone or other electronic device (except for medical reasons) in a playing room during play. It is not adequate to turn your cell phone, blackberry, iPod, radio or whatever, off. You must not have it with you. As in the past, we will provide a place for you to leave your cell phone before you enter the playing room. Note that this restriction applies to kibitzers as well as players.

In order to ensure compliance with the rule about no electronic devices, the USBF has purchased a wand that can detect the presence of metal, and will be engaging in random inspections of players, using the wand, both during and immediately before and after play.

With regard to kibitzing, the Security section provides that no-one may kibitz at a table that is being shown on Vugraph or at a table that is using the same boards as a match being shown on Vugraph. As a practical matter, this means that no one will be allowed to kibitz at the table after the Round Robin. If you want to kibitz, volunteer to be a Recorder at a non-Vugraph table during the Round of 16 of the USBC and Playoff 1 of the USWBC or volunteer to be a Vugraph operator at a table that is being shown on Vugraph. The tables that are not on Vugraph will be playing the same boards as those on Vugraph and we will be entering the bidding and results into the computer in order to show them as USBF web vugraphs. You will not be assigned as a Recorder or Operator for a match involving a relative or good friend, but you will be seeing the same boards that are being played in all the matches so you will be able to discuss them later.

Once Vugraph coverage starts, we will have a computer with overhead projector in the Hospitality Suite so that you can watch the Vugraph if you didn't bring a laptop or if you prefer to socialize while watching.

## More Cavendish Hands from Bart Bramley

Justin and I had a couple of great results defending 1NT doubled. On the second board of the event I held $\wedge$ AQ765 A93 - 107 \& 974 , as dealer at favorable vulnerability. Following the principles espoused by my longtime friend and partner, Sidney Lazard, I opened $1 \boldsymbol{A}$. LHO, with a full 17 HCP , overcalled 1 NT , which Justin doubled on his 9 HCP . All was well when Justin led the spade jack from Jx, with the suit 3-3. When the smoke cleared we scored +500 for down two on what was a nothing hand at most tables.

Later, I had A109 $109 \star A K Q 1082 \& A 10$, once more at favorable vulnerability, this time in third seat. Justin passed and RHO opened $1 \star$. I briefly considered overcalling 3NT immediately, but I decided to start with a double. (How can you ever defend $1 \star$ redoubled with this hand unless you double?) The auction continued $1 \wedge-\mathrm{P}-1 \mathrm{NT}$. I doubled again and everyone nodded. I cleared diamonds (declarer had J9xx) as partner showed a club card, which turned out to be the king, so we held them to one diamond and four heart tricks. Another +500 for down 2 , and only a few people bid and made 3NT our way.

On the first hand of the last session I held $\uparrow$ VOID $\vee$ Q764 $\uparrow 982 \approx$ AK10852, in second seat with nobody vulnerable. RHO opened 1 NT ( $15-17$ ), which I doubled to show spades and diamonds, or hearts and clubs. LHO redoubled, partner bid 2 (pass or correct), RHO doubled, I bid $2 \downarrow$ (showing hearts and clubs). I wasn't liking the auction much and it got worse when LHO doubled, partner bid $2 \boldsymbol{A}$, and RHO doubled. What now? I considered that if partner had a spade onesuiter he could have passed over the redouble and then bid his spades, which would be unambiguous. But if he had a spade-diamond two-suiter he could have redoubled $2 v$ to get me to pick. Finally I decided that he MIGHT choose to bid a one-suiter this way, so I passed. Right! Justin had $\uparrow$ KQJ85432 $\vee 92 \bullet 106 \leadsto 4$. The opponents could actually beat $2 \boldsymbol{\wedge}$ with a trump promotion, but they messed up and we made an overtrick for +570 . It was the only plus score in our direction and a huge swing for us. That's living right.
