# **USBC/USWBC ROUND ROBIN SCORING from Jan Martel**

Scoring for the Round Robin in the USBC and USWBC this year will be done by the program on our website, based on score sheets that the North player completes at each table. For those of you who played in the USBC last year, the score sheets will look about the same as they did then. However, there is a significant difference this year – these are now **official score sheets** and **must** be turned in before you can start your next match. Although you will have an opportunity to correct an incorrect score later, it will be much easier for everyone if you are initially accurate. Please check the results with your opponents at the end of each match before turning in the score sheet.

After each round, the scores on the score sheets will be entered into the computer and the computer will calculate IMPs on each board and VPs for the match. These results will be posted online and in addition we will print a scorecard from the match for each team. The VP results will be entered on a cross-table (two for USBC Round Robin 1 which will have two divisions) on the USBF website. We will have computers with overhead projectors in the lobby areas of both the Open and Closed rooms that will project these cross tables on the wall.

If you disagree with a posted result, you must find the captain of the opposing team and the two of you must submit a score correction to one of the DICs, within one hour after the session in which the match was played.

# **USBC Round Robin Lineup Submission Procedure**

This year, as for the last few years, we will be using a "blind" lineup submission procedure for the USBC Round Robin. This means that you will not know you opponents for a match until after you have submitted your lineup. Before each "clump" of matches, you will hand your lineup in to one of our logistics staff (Jan, Rena, Jeff or Tom) and he or she will give you your guide cards for the matches in that clump.

With the exception of the final clump of 4 matches in RR2, you may change your lineup between matches of a clump in either the Open of Closed Room. During the final clump of 4 matches in RR2, the Closed Room teams will be sequestered and may not talk to their teammates. No substitutions will be allowed in the Closed Room during those matches. You may make substitutions in the Open Room at any time. Note that the substitutions must be included on the lineup you submit for each clump. You may make substitutions during a match or clump **only** for emergencies and with permission from a DIC.

# USBC FORMAT AND MISCELLANEOUS INFORMATION

The ITT Conditions of Contest Committee has approved the following format for the USBC Round Robin: The 22 teams playing in the Round Robin will be divided into two 11 team groups of roughly equal ability. Each team will play a 7 board match against each other team in its group. These matches will be played on June 1st and 2nd. The IMPs in each match will be converted to VP's using the USBF 7-Board VP Scale. At the conclusion of this RR, the bottom 3 teams from each group will be eliminated. The remaining 8 teams from each group (16 in all) will complete RR play. Each continuing team will play a 7 board match against each continuing team from the **other** group, on the second half of Saturday, June 2nd, and the first half of Sunday, June 3rd.

After completion of play, each of the continuing teams will have played a 7 board match against all other continuing teams. In addition, each of the continuing teams will have played 3 matches against eliminated teams. The continuing teams' final scores will be the full VPs earned against other continuing teams, whether those VPs were earned in the first day and a half of play or in the final day of play, plus a percentage of the VPs they earned against the eliminated teams. That percentage will depend on the scores of the eliminated teams - VPs earned against a team that did better will count more. The Round of 16 will start the afternoon of Sunday, 6/3, and take 1 1/2 days. Each of the Quarterfinals, Semi-Finals and Finals will take two days. See the tournament schedule on page 10 for exact times of each session of play.

5. Maureen received a higher salary increase than Ms. Needham, but she got a lower percentage raise than Ms. Settle.


6. Ms. Fuller did not receive the \$3400 salary increase. Ms. Needham received a \$4200 salary increase.

To celebrate the International Team Trials being in Chicago ... and to get in a little extra practice before the start of play, Chicago's "hostess with the mostest" (You know who.) held a small dinner and bridge party at her home in Hinsdale on Wednesday evening.



There was a very interesting hand in the second round of the warm-up session that illustrates the difficulty in handling high level preempts. On the surface, the West hand is a fairly standard  $3 \bullet$  call at favorable vulnerability. It appears to have seven losers and six winners. However, the club holding (JTx) makes the hand a more attractive  $4 \bullet$  preempt, especially given the modern use of aggressive preempts.

At one table, West opened  $3 \blacklozenge$ . It went pass, pass and South was able to balance with  $4 \blacklozenge$ , allowing North to bid an easy  $6 \blacklozenge$ .

At the other table, West opened  $4 \bullet$  and South balanced with a sensible  $4 \bullet$ . Would you do anything different?

Now, North knew slam was likely, and holding a double diamond stopper along with the ace of partner's suit, North decided to bid 6NT. This, of course, failed miserably when East had an easy king of clubs lead.

One more time, maximum pressure pays off big!




# **Appeals Committee Number One**

This case involved a concession of a trick in a 6S contract for down one N/S Vul. in a 4 card end position whereupon the Dummy called attention to the fact that Declarer had all of the tricks (which is not a violation of the laws as after a claim or concession is made, any player -including dummy- may call the director). This was the 4 card end position with N to play and it was clear that N knew that the two diamondc in dummy were good:

The Directors ruled that pursuant to Law 71 C (Implausible Concession) that the trick conceded could not be lost by any normal play of the remaining cards and adjusted the result to 1430 for each side. The Appeals Committee unanimously agreed with the Directors that considering the class of player involved that he would not have lost any tricks by any normal play of the remaining cards. That it would be irrational to play a H to the J at trick 10 which is the only line which would result in a loss of a trick.



# "Save"ing Grace ... A Hand from the USBC



In the Schwartz - Einberg match, Cohen and Berkowitz did well to find the six heart save over five spades holding (between them) the ace, king and queen of clubs, as well as the ace, queen and jack of hearts.

Their teammates made five spades vulnerable for +650, while they went down only three for -500 in six hearts.
