You can see the current scores in the USBC and USWBC online at http://www.usbf.org/ as each round is completed and entered into the website scoring program. See the **USBC Round Robin scores for the Bears** and **USBC Round Robin scores for the Bulls** and the **USWBC Round Robin scores**. On the Cross tables, click on a score to see the scorecard for that match. On the scorecard, click on a result to see the hand record (hand records will be available online about two hours after the completion or play). Scores should be up about an hour after the completion of each round of play, but please be understanding if they aren't - we're doing our best, but sometimes accidents will happen.

You can also get to the cross tables by clicking on 2007USBC and 2007USWBC under "Web Vugraphs" in the left hand column on each page of this site.

In addition, you can read the daily bulletins on-line by clicking on the Daily Bulletins link. We are posting the Team *Trials and Tribulations* as soon as it is ready to go. Most often, this will be in the middle of the night the day before the issue is available in hard copy. It is interesting to note that the double dummy analysis on the hand records shows that by guessing perfectly (or knowing all the cards as in double dummy, of course), East/West can make six no-trump, six spades, six hearts, four diamonds, and four clubs.

- How often do you see a board where one side can be successful at the four level or higher in all four suits AND no-trump?
- No wonder there were so many swings on this hand.

# Some People Just Can't Follow "Directions!"

If the 7th round scores in the yesterday's USBC don't make sense to you, it could be because there was a double forfeit in the Hollman-Weed match. Both teams sat the same way as their teammates! (In a manner of speaking, you could have had TEN cell phone calls for the same price.)



### Squeeze for Seven Notrump ... from the USBC

This was indeed a strange board. In most of the first day matches, one table would get to four hearts while the other got to the heart grand. Taking thirteen tricks in hearts is easy. You simply set up the long spade for the thirteenth trick.

The hand record indicates that 7NT is cold... and it is. It just isn't that easy to see. Whatever South leads, North is hopelessly squeezed in the black suits.



You don't need to be a magician to pull this one off! With the queen of spades in the pocket, all you need is a 3/3 break or for one opponent to hold three clubs and four spades.
