Welcome to the 2021 Women’s United States Bridge Championships. Here, in Schaumburg, we will select teams to represent the United States in the 2021 Venice Cup in Salsomaggiore Terme, Italy from March 27th-April 9th, 2022.

There are 4 teams registered to compete for USA1 and USA2 in the Venice Cup. There are no byes. All of the 2021 Beth Palmer Women’s USBC will be held face to face. **The KO USA1 stages will be 2-day, 120-board Semifinal and Final KO matches. The KO USA2 stages will be a 2-day, 120-board KO Semifinal in which the USA1 Semifinal losers will play, and a 2-day 120-board Final between the USA1 Final loser and the USA2 Semifinal winner.**

This event is long overdue and we are gratified to be here.

In the best interest of our players, all USBF face-to-face competition will require vaccinations, will be played on tablets using the LoveBridge software, and will have only two occupants per room during play. The LoveBridge software team will be on hand to help with any issues that may arise.

While the USBF Board of Directors and the tournament organizers do their best to make this event the fairest Competition year after year, only YOU, the players, can uphold the high level of ethics, camaraderie and sportsmanship for which United States bridge is known worldwide. I ask that each of you keep this in mind throughout the event.

Let the games begin!





Hospitality Suite

Because of Covid, we won't be able to provide the full, wonderful hospitality we have in the past, but we will do what we can.

Hosts Evvie Gilbert and Maya Alela for the Open and Women's and Julie Arbit and Christian Jolly for the Mixed and Seniors will be in our usual hospitality suite (Room 2321). They will provide grab and go breakfast and lunch each day'

Breakfast: From 8-10 am. There will be individually packaged cereal, fruit, hard boiled eggs, bagels, and surprise treats. Also individual butter, jam, peanut butter, and cream cheese, as well as condiment packages. They will be making coffee and will have individual packages of sugar, sweetener, and dairy & non-dairy creamers. For those of you who prefer Keurig coffee, that will also be available in the hospitality suite. We are limiting access to 6 players at any one time, so we ask that you come to the suite, pick up a large to go container and put the smaller packages in that to take with you as quickly as you can, and then go someplace else to eat. **Masks that cover your nose & mouth must be worn in the Hospitality Suite at all times.** There will be a hand sanitizer station near the door and we encourage you to sanitize your hands before choosing what to take.

Lunch: From 2-4 pm (the first half of play each day ends at 2:35; we encourage those of you who are sitting out the 2nd quarter to go early). There will be a main dish (sandwiches, chicken, main dish salads, pizza) as well as individually packaged tuna salad, green salad, cheese, fruit, and berries. Also all the individual packages of add-ons we have for breakfast. Water and soft drinks will be available in refrigerators.

Let us know what you want: If there is a menu for a future day's lunch hanging on the wall outside the Hospitality Suite, please mark what you want, so we have a better idea of what to order.

Playing Rooms & Player's Break Room

We will have bottled water in the playing rooms and if there is a refrigerator in a playing room we'll stock it with soft drinks.

We will also have bottled water in the Player's Break Room (1321), as well as soft drinks, nespresso, some packaged snacks, and some fruit.

Masks that cover your nose & mouth must be worn in the Player's Break Room at all times, so you may not eat and drink in the room.



KIBITZING ON LOVEBRIDGE

You can follow the USBC on the <https://vugraph.lovebridge.com/> website. The stream is delayed; go to the schedule below for starting times for each segment.

Popcorn time!

Do you want to listen to commentary? Search for the TV icon! It will send you to the page where you can choose from the available live commentary. If it doesn't do anything, no one is commenting.

Nail biting!

Do you want to be deeply involved? Choose the "Match view" at the starting page of your event. Your screen will be divided into four small screens – two of them showing the two tables of the match you choose, the other two having the scoresheet for your match and the current scores of the other matches. In the 2x2 view you can also personalize the content in all your windows. (The 2x2 view is not available on mobiles.)

Think together!

When watching a table, click on a name and choose "Kibitz". Instead of seeing all 4 hands, you will see what the player sees, and you can decide what you would do and see whether your chosen player agrees.

More Information:

Be well informed and tell your friends: while following the play, you can click many items. The image of the sticker with the number of the board (upper right) takes you to the results of the board, in the bottom right corner the arrow takes you the scoresheet, the DDS shows the double dummy analyses, beside that there is a button for the other table of the same match, at the top left corner you can see the bidding with alerts and the explanations (mouse over), the tricks already played, and the double dummy analysis for the available number of tricks with the par score.

Navigation icons:

While surfing here and there in the vugraph, or amongst the archive sessions, there are icons to help you. You can always go back to the main page with the "house" or to the standings with the "scores". If you cannot see the icons, move your mouse, or touch your screen and they pop up immediately. There is also a built-in back button because the back button of your browser will always take you to the starting page. If this is not what you wanted, push next in your browser and you can continue where you were.

Replay:

After the event you can find every board from every table easily. While replaying the hands, the only surprise can be the way "next board" button works. If you have arrived from a scoresheet, it navigates through the scoresheet. If you have arrived from a screen where the results were shown for a given board then the same buttons move you through list. Push every button and enjoy!

Zach's partner was **Nicole Qian** (waddleseal), a high school student from Florida and a **young Women player!!** The opponents were 18 year old Brandon Fong (bcipher) from New Jersey and Puneet Gupta (puneetsan) from India.

On BBO only three of sixteen pairs bid four spades. Zach was the only declarer to find the trump coup position to make his contract and win 9 IMPs on the BBO IMP pairs scoring.

South led a high diamond and switched to a heart. Zach played the HQ from dummy. Brandon won the HK and returned a diamond. Zach trumped with the S5 and played the SK. North won and returned another diamond. Zach trumped the diamond return and cashed the SQ, getting the bad news in trumps. The position is shown below:

Zach led a heart and played the HT from dummy. When this held the trick, he cashed the HA and led the DJ trapping North's ST3 under his SJ6 to take ten tricks.

Meet the Players...

Beth Palmer was an Administrative Judge with the Equal Employment Opportunity Commission for 24 years, hearing complaints of employment discrimination. Prior to becoming a judge, she was a lawyer in private practice. Admired in the bridge world for her judicial temperament, Beth generously gave of her time throughout the years to serve in numerous administrative positions with the USBF, ACBL, and the Washington Bridge League.

Beth began playing bridge in law school in 1977 and her first serious partner was Bill Cole. Two years later, she played with Bill at the Norfolk, Virginia, nationals and her team made it to the round of 16 in the Vanderbilt. Lynn Deas reported at the time that "Beth was the talk of the tournament, won more than 100 masterpoints, and made Life Master."

Away from the bridge table, Beth enjoyed reading and sports, but her primary interest was her family... daughter, Julie Pettis and husband, Bill Pettis. Beth served as Julie's Girl Scout troop leader for six years and was coach of her basketball team for five. Beth and Bill (Buffalo) lived in Silver Spring, Maryland.

Beth was serving a member of the United States Bridge Federation Board of Directors when she lost her battle with cancer in 2019.

She is greatly missed. This event is named in her memory to honor the many hours she devoted to making this game the best it could be.




Update on Bob Hamman...



Stephanie Doran Scott, Petra Hamman's daughter, reported yesterday that Bob is improving every day.


Yesterday Stephanie posted that:

MENU



You don't have to shout for a director; you can call them by clicking on the "Whistle" button.

In case of a misclick don't panic! Call TDs and they will try their best to help you. (*)

Press here to make the claim window transparent so you could see the already played cards.


To hide your screen from view, click this icon.



Click - or + to adjust the number of tricks.

* According to the rules there are some cases when your bid or played card can be taken back. TDs know the relevant rules.

Don't worry if you misclick during the bidding; you have a few seconds to cancel the bid. You can change this timeframe at Settings/Bid Menu.



You can tap on the bidding panel to alert your calls. You can even give written explanations. Find more details in the explanation guide.



Whenever it's your turn, you can play a card, even if the bidding panel or the cards from the last trick are still in the middle of the screen.

At the top left corner you will always see the vulnerability and the dealer from your perspective (you are at the bottom).



You can change how to play your cards in the Settings Menu.



The system will remember your settings when you play next time.



You can review the previous boards any time.



Explanation

User guide - self alert

The logic of alerts and explanations in the LoveBridge system can work multiple ways. You will use it **with self alert and screened tables**.

You only alert your own calls. Both opponents can ask for more information, and they will always know the same details about bids.

Alerting

When you want to make an alertable call, you have multiple options:

You can **tap in the input field** and type your explanation here.

You can **tap on the alert button** so that your opponent knows it's alertable.



You can **tap the envelope button** and, after placing your call, the bridge keyboard will pop up. Here you can type your explanation.

Note: Your call will be alerted as well.

Bridge keyboard

Common bridge expressions are organized in seven categories to help you type bridge related messages with only a few taps.

You can type any other message using a traditional keyboard.



Multiple words in every category

Bidding Panel

The closed envelope shows that you have an **unread message**.

You can ask for further information  by simply tapping the send button.


Make sure you only press the send button when you would like to ask a question.

You can use the chat to send private messages to your opponents, or you can chat with the entire table.



You can find the chat in the top left corner of the screen. You can open it by tapping the chat bar.

You can only send private messages to your partner when you are not currently playing any boards.

When writing an explanation, you can press the “done” button to switch back to the bridge keyboard.



To write a question mark:
You can use the shift button, a long press on the question mark or switch to the symbol keyboard.



Frequently Asked Questions

How can I unalert my bid?

You can press on your bid, turn off the alert switch and tap on the send button.

ALERTED



Can my partner see when I ask for further information?

No, your partner will only know that your opponent has changed the explanation.

Can I take cards back?

There is no undo button, you can use double tap or drag and drop to make sure you play the card you want to play. You can call the director to take your card back, and they will inform you about applicable rules.

Can I take bids back?

There is a cancel time (can be set to 0-5 seconds) for the bid, when you can review your call, and take it back if it was a misclick. No other player can see it during these seconds. Directors can take back bids as well.

Why can't I see the bidding during playing?

According to the rules, you are not allowed to see the bidding once the playing has begun. You can only see the bidding before you play your first card.

Why can't I see my partner's cards when I'm the dummy?

Just as playing with cards, you can not see the declarer's cards when you are the dummy.


