# We Remember:



Welcome to the **2020 Justin Lall Online Teams 1**. The USBF has run two Online Knockout Events since the start of the Pandemic and both were highly successful. This event, our third, marks the first of many to be named in memory of Justin Lall. Justin was an amazingly talented young player and great friend of the game. While we mourn his loss, with this event, we celebrate his life.

**Major change from USBF INV1 & INV2:** The move from BBO to RealBridge: You can read about RealBridge at <https://realbridge.online>. On RealBridge, the video is integrated with the play which eliminates the need to set up chat rooms for screenmate chat.

### Event Schedule and Format

- JLall1 will be held from November 6-9 and 13-16
- Play each day will start at 1:00 pm EDT and end around 10:00 pm EDT.
- Will Watson is the DIC. Jan Martel is the Tournament Organizer.

### Round Robin Stage 1, Nov. 6th to 8th:

Everyone plays 3 days of a "split field" Round Robin with 10 board matches; there are two Round Robin groups, the **Indians**, named for Justin's heritage, and the **Cowboys**, named for his favorite football team. Teams will be assigned to the two groups based on a "draft" by the top two teams (chosen by a vote of all teams). The top 5 teams in each group qualify for the KO Round of 16. The bottom 6 teams in each group are eliminated. The 5 teams in the middle of each group ("bubble teams") will play in Stage 2 of the Round Robin.

### Round Robin Stage 2, Nov. 9th:

Each bubble team plays a 10 board match against each bubble team from the other group, scored at VPs with carryover from the first 3 days. The top 6 teams qualify for the Round of 16. The bottom 4 teams are eliminated.

**Knockouts, Nov. 13th-16th:** one 56 board match per day. *If both of the finalists want a longer match (60 or 64 boards), we will have that.*

There will be a Captains' meeting on Nov. 11th to set the KO bracket.

- During the bidding and play, each player will be able to see & hear their screenmate - (N&E, S&W).
- There will be no real-time kibitzing allowed for any match. RealBridge has a way for kibitzers to watch a match after a delay. For the Round Robin, viewing will be delayed until each match is complete so kibitzing does not provide "state of the match" information. For the KO, each board will be shown once all tables have completed it.
- This event will be "open notes" - players may consult their bidding notes, SSF, and convention card during the bidding. Other aids to memory (for example, lists of percentages, calculators, notes about carding) are not allowed. If a table runs over the time allowed and one player has spent time consulting notes, that player's team will be initially deemed at fault for the slow play.

Online play presents challenges. While the USBF Board and the tournament organizers do their best to make our events the fairest Competitions, maintaining this standard will always be the responsibility of the players. We count on you to uphold the high ideals of ethics, camaraderie and sportsmanship for which United States bridge is known worldwide... and which would make Justin proud!

I will do my part to uphold these standards. Please keep this in mind throughout the event. Good luck everyone! Let the games begin!




## Ethics Statement

We're not trying to provide security for this event, as we do when we sometimes have "real" events online. However, the provisions of the USBF General Conditions of Contest regarding ethical obligations and possible penalties still apply to this event. The USBF has appointed an Ethics Investigation Committee that will review any complaints about ethics violations. If the EIC concludes that a player or pair was acting unethically, they will report to the USBF COO, who may refer it to the USBF Recorder. Either the COO or Recorder may bring a Charge against the player to the Board of Directors, who may place a player on probation, suspend, or expel a player for cause.

- Normal USBF System regulations apply to this event.
- This event is governed by the USBF General Conditions of Contest and Special Conditions of Contest for this event.
- The ACBL Open+ Convention Chart applies to this event.

# Kibitzing on VuGraph...

There will be delayed kibitzing for all of the JLall1 event.

To kibitz, go to <https://kibitz.realbridge.online/>, enter your name and click on Log In. That will take you to a screen where you can select the event to kibitz (*we do not know whether there will be events with delayed kibitzing other than the JLall1 running concurrently*).

After you select Kibitz JLall Online Teams #1, you will be taken to a lobby where you will see a list of tables on the left and a chat box and list of people in the lobby on the right. The table listing shows the team & player names at each table, as well as the board and trick that table is on (that's in the middle of the table, immediately under the table number). Click on a table to kibitz it.

At the table, you will see a hand diagram, and the bidding and play as it happens. You will not hear or see the players.

There is a chat window on the right of the screen (if your browser window isn't large enough to show it, you can click on the "chat" icon immediately above the UNDO button to open the chat window. For now, anyone can type chat into the chat window. We may have designated commentators for late stages of the event.

Some things you can do to get more information:

If there is an asterisk next to a bid, that means it was Alerted or Explained. Click on the bid to see the explanation if there was one.

-- "Rewind" the play using the slider underneath the "table" with hand diagram. just move the vertical handle on the slider to the left to go to earlier tricks.

-- Click on the "Scores" button to the left of the South player's name, you will get a scorecard for the match so far. You can use this to get lots of information:

----Click on a board number to see the hand record and results at all of the tables.

----You can also click on a number in a yellow box to get to the hand record from some screens.

----In the hand record screen, click on a result to see the bidding and play at a specific table.

--In the upper left corner:

----Click on the yellow box with 4 little boxes to get the match scores for all the matches (that will be IMPs and will not include scores from previous rounds).

----Click on the yellow box with 3 bulleted lines to get Cross-IMPs for the pairs (that will be just for this match).

The Scores information is also available in the lobby using the button at the upper right, in case you want to check on scores before deciding which table to watch.

# USBF Appoints Ethics Investigation Committee







# Some Suggestions For Dining at Home Between Sessions! Pandemic Pleasures...



CHOCOLATE  
HAZELNUT  
PANNA COTTA



## INGREDIENTS

- 2 sheets leaf gelatin
- 2 oz (57 g) bittersweet chocolate, finely chopped
- $\frac{3}{4}$  C (135 g) chocolate hazelnut spread, like Nutella
- 2 C (473 ml) heavy cream
- 1 tsp (5 g) Amaretto liqueur

### *Garnish:*

- 1 C (118 g) sweetened whipped cream
- $\frac{1}{4}$  C (25 g) chocolate shavings

## DIRECTIONS

Submerge gelatin leaves in ice water and let soak until softened, about 10 minutes. Place chocolate and chocolate hazelnut spread in a large bowl, stir to combine; set aside. Place cream in a medium saucepan and let just barely come to a boil; remove from heat. Pull softened gelatin sheets from water; squeeze out excess liquid. Add gelatin to cream, swirling to melt and combine. Immediately pour cream mixture over chocolate mixture. Allow cream and chocolate mixture to stand a few minutes, then whisk until smooth and blend in Amaretto. Transfer to 6 individual serving glasses. Refrigerate at least 2 hours before serving; cover with plastic wrap if refrigerating overnight. Garnish with whipped cream and chocolate shavings.

*Prep time: 15 minutes.*



## CHOCOLATE TRUFFLES



### INGREDIENTS

**16 oz (454 g) Valrhona or Scharffen Berger semisweet or dark chocolate**

**1 C (237 ml) heavy cream**

**½ tsp (2.5 g) black currant extract**

**½ C (56 g) Valrhona or Scharffen Berger unsweetened cocoa powder\***



### DIRECTIONS


Line a baking sheet with waxed paper; set aside. In a food processor, pulse chocolate into small pieces. Heat cream in a small heavy saucepan over medium low until bubbles begin to appear around pan edges and cream begins to steam. Pour cream over chocolate in food processor. Let stand 10 minutes, then blend until smooth. Add extract; pulse to blend. Pour into a shallow bowl, cover and refrigerate until firm, about 3 hours. Using a spoon, scoop out mixture and quickly roll into rough balls. Place on baking sheet; if very soft, refrigerate another 30 minutes. Place cocoa powder in a shallow bowl; roll balls in cocoa to coat. Refrigerate in an airtight container up to 2 weeks. Serve at room temperature.

\*You can also replace the cocoa powder with hazelnut or walnut meal.

*Prep time: 20 minutes.*



## CHOCOLATE LAVA CAKE



### INGREDIENTS

**3 T (43 g) butter, melted**

**Cocoa powder**

**1 C (180 g) good quality dark chocolate, chopped into small pieces**

**¾ C (172 g) plus 2 T (29 g) butter, in small pieces**

**4 lg eggs**

**4 lg egg yolks**

**1 C (192 g) fine granulated sugar**

**1½ C (187 g) flour**



### DIRECTIONS

Brush melted butter on the inside of eight 1-C (225-ml) capacity molds; place in refrigerator or freezer to chill, then brush more melted butter over cold butter. Sprinkle a little cocoa powder in molds; shake to completely coat molds and tap to remove any excess. Slowly melt chocolate and butter together in a saucepan over a pan of barely simmering water. Remove from heat; stir until cool; let stand 10 minutes. In a large bowl, beat together eggs, yolks and sugar until so thick that a spoon dragged through mixture leaves a trail. Sift flour into egg mixture; beat to incorporate. Pour melted chocolate into egg mixture one third at a time, beating well between additions, until completely combined. Evenly divide mixture among molds. Chill molds at least 20 minutes or up to overnight before baking. Heat oven to 375°F (200°C). Place molds on a baking sheet and cook for 10-12 minutes (add 5 minutes if baking from frozen). Remove when tops are crusty and start to pull away from sides; loosen gently until you can easily unmold them on serving plates, garnish and serve. The “lava” centers will remain soft.

*Prep time: 35 minutes.*

*Cook time: 10-12 minutes.*

*Makes 8 servings.*









On October 19th, Board 2 from the Alt Mixed V RR1 was interesting. In Hinze v Unicorns, Migry and David Berkowitz (mikeyb), found 3NT North/South when Ellen Hessel (Chongo) declined to bid her 8-card spade suit opposite her partner's weak two heart opening.

Ira led the H6 and Migry quickly collected six clubs, four hearts and two pointed aces for +690. She probably did not expect to win 11 IMPs on the board since the slam was cold without a finesse.

Surprise! In the other room, the auction went differently. B Myers (bazzam) opened the same weak two in hearts as Ira Hessel, but Sally Brock (saralindaj) responded 2S with her 8-card suit. Greg Hinze doubled and Kay Enfield (cx107) bid 3C. Hinze cued 3H; Myers bid 3S; Enfield bid 3NT and Brock bid 4S. Hinze resignedly doubled and the auction ended.

Greg led the best lead for his side, the SA. He continued with the S5, Brock winning dummy's king. Brock played a diamond to the ten, losing to the jack. Hinze cashed his HA and Brock conceded one down for -100.

In the Donner/Edmonds match, Gary Donner and Cecilia Rimstedt reached 3NT where Zach Grossack (germs34) like the other Easts, opened a weak 2H. Donner passed and Botta, like Ellen Hessel, took no call with the 8-card spade suit. Rimstedt collected 13 tricks for +720.

In the other room, Joe Grue, East, again opened 2H. Sandra Rimstedt responded 2S and Judi Radin, like Hinze, doubled. Grue raised spades and Joel Woodridge (firechief) jumped to the club game.

Grue took all 13 tricks for +620 and a loss of 3 IMPs.

Donner and Enfield had clumsy hands after partner's take-out double. 3C is an underbid. An alternative would be to bid 3H if partner works out it's a cuebid in the suit with values as a try for 3NT. Perhaps Wooldridge took the "simple yet safe" route by bidding 5C. Unfortunately that left no room to explore for the slam.

There is no questions that bidding a slam on these cards is much tougher once both hearts and spades have been bid.

# A Socially-Distanced Squeeze! Junior Bridge at its Best!

On Monday, October 19<sup>th</sup>, in a practice session of the USBF Junior (Under 21) program, Kai Eckert (North) and Daniel Balof (South) had a slightly tangled auction to reach 3NT with the weaker hand (North) emerging as declarer.

Daniel opened 2C and Helen Chow (West) threw a monkey wrench into the auction by overcalling 2S. North passed showing some values, and Nathan Chow (East) had nothing to add.

South faced a quandary: how to reopen. 2NT works best if the auction ends in a notrump contract. The S:AT can produce a double stopper if North holds as little as Jxx. On the other hand, a reopening double makes it easier for North to introduce a four-card heart suit with the added option to penalize 2S. (*Note that in this case, with the favorable major suit position, 2S might actually succeed.*) North had notrump distribution and did not have great defense. Kai bid 2NT, leaving room for his partner to bid a new suit. Daniel, with a spade stopper and no long suit of his own, bid 3NT. Lucky for North/South, as the cards lie, it does not matter which hand becomes declarer.

Kai may have held a “weak” hand, but he demonstrated that he is a “strong” declarer. The opening lead was the S9, ducked in dummy and won by West with the jack. A second spade was played to dummy’s ace. Declarer has seven top tricks and can establish a heart trick by driving out the ace. The ninth trick will have to come from either diamonds or hearts.

If West has the HA, she will always be able to hold at least three spades and there would be no play for the hand. Therefore, North properly played for the HA with East.

If West doesn’t hold the HA, there is a good chance that she has the DQ to go along with her six-card spade suit. In that case, cashing four rounds of clubs will put a lot of pressure on West. Declarer began cashing clubs and he found the perfect layout for a three-suit squeeze on West.

If West discards three spades on the clubs, declarer can play for the heart split and drive out two high hearts, losing only two spades and two hearts. If West discards a heart, declarer will be able to drive out two hearts without giving up the lead to West.

West discarded a heart on the second club and a spade on the third round of clubs. On the fourth club, she decided to part with a second heart. Declarer read the position perfectly. He played a heart to the king and East’s ace. Nathan returned the H3. Kai rose with the HQ and played a third round of hearts to set up his ninth trick.

This hand was played sixteen times on BBO and only two pairs found the play to make 3NT.

Well played, Kai. These kids are going to be a force to reckon with in the future!

Board 13 provided the chance for a swing but only by bidding slam on a wing and a prayer.

In Donner/Edmonds, Grue and Sandra Rimstedt of the Donner team bid 6H and got lucky when trumps were 2-2 and the SQ came down in two rounds.

With all that, it still might have been defeated had Radin led a low diamond from her ace, but she made the "normal" lead of the DA and Rimstedt took 12 tricks.

At the other table, Botta and Zach Grossack stopped in 4S from East, protecting the DK from the low diamond lead from North.

Donner led a low diamond from South but nothing could stop 12 tricks and 13 IMPs to Donner.





If the explanation you are about to make is one you made previously (for practice "previously" means during this session of play; we hope that for the real event it will include all previous sessions), you do not have to re-type it. Click on that square to the right of the club symbol to get to a library of previous explanations. Click on one to put it in the explanation box. Once you have explained and/or alerted, click on a bidding card to make your bid. You only need to alert if you are not explaining - an explanation without an alert will look the same to your opponents and in the bidding record as an explanation with an alert.
