Mask Requirements for F2F Play in Schaumburg:

Masks are required in all public areas of the hotel: the lobby, corridors, elevators, as well as the Hospitality Suite and the Office/Break Room where masks must be worn at all times. Therefore, there will be no eating or drinking in those rooms.

Day

Our attorney has advised us that the Cook County Mask Mandate forces us to require masks in the playing rooms. Therefore:

Masks are required in playing rooms. If you are observed not wearing a mask in a playing room, there will be a 2 IMP penalty for the first offense, a 4 IMP penalty for the second offense, an 8 IMP penalty for the third offense, and a 16 IMP penalty for the fourth and subsequent offenses; If you and your opponent agree to something other than both wearing masks, any IMP penalties for not wearing a mask will apply to both of you equally and there will be no other penalties. You may remove your mask briefly to eat or drink. However, if you call for a director (for any reason), and you are not wearing a mask when the director enters the room, the penalty will apply to your team for your next match in the event. There is no eating or drinking in the playing room when the Director is present.

In addition, anyone who is penalized more than twice (over the course of the entire event) in situations where their opponent was wearing a mask while they weren't, or where the director was called, may be subject to additional conduct penalties.

You should bring masks to the tournament with you; We will not be supplying masks.


Board 3 of the first Round Robin match was most often played in 3NT by E/W. Making 3NT requires some accurate guessing and good timing. Six of the eight 3NT declarers made their contract, some with overtricks.

In a typical 3NT scenario, Ron Smith and Ljudmila Kamenova had а straightforward auction where Ε opened 1NT; West bid Stayman; E denied a 4-card major; W bid the NT game. Enfield led the S4. Ron won the nine in hand and continued with the SQ. Enfield ducked the spade and Smith switched to the HK. Hinze won 600 the HA and returned the CJ. Smith ⁶³⁰ won his ace and led a heart. Enfield won the HQ, cashed the SA and exited with a spade. Smith played dummy's

heart winners, discarding small clubs from his hand. When Enfield's CQ appeared, Smith took the last four tricks for +630. At the other table of this match, Mike Cappelletti took eleven tricks in 3NT on an identical auction and similar defense. 1IMP to Hinze.

The Hammond/Rosenthal match provided a more unexpected pair of results for the kibs.

Nicolas Hammond opened 1S with the South hand. Kristen Onsgard responded with a semi-forcing 1NT. Migry overcalled 2C. If Hammond passes, Willenken might choose to bid 2NT which Migry will likely raise to game. Hammond was not timid. He freely bid 2D over 2C. Without a fit for partner, Willenken chose to defend. 2D was passed around and the defense collected eight tricks, scoring +150 E/W... not enough when cold for a vulnerable game.



Jacqueline Chang bid 2C (presumably Stayman) and Gettleman happily passed, content to play in his six-card suit. Rosenthal was still a believer. He could have passed out 2C and E/W would score +110. Instead, he doubled again, and E/W scored +380. 6 IMPs to Hammond

If Chang trusted her partner's 1NT bid, she could have redoubled and scored +760. They have nowhere to run. But its always hard to redouble with a singleton trump. Redoubling would have produced a 12 IMP gain.

General Face-to-Face Tournament Information to Players

9 Board VP Scale

The USBF Board of Directors met earlier this week and confirmed:

1. Face-to-face play in Schaumburg will be with 2 players per room.

2. Players will not be required to get Covid tests, but will be provided with information about where they can be tested (in Woodfield Mall) if they want to be. Staff will be tested approximately once a week.

3. We will comply with the Illinois mask requirements, which currently require masks in public areas indoors. Our default will be for both players in the playing rooms to wear masks, but if the 2 players in a room agree on a different rule we will allow whatever they agree on, assuming that is in compliance with the Illinois requirements.

4. We will ask each player to sign a Covid-related waiver of liability form before they start play. Jan will be sending the text of the waiver to all of you in the next day or so, and will have printed forms in her office (room 1321) at the Hyatt for participants to sign.

5. Hospitality will be limited - "grab & go" breakfast and lunch will be distributed in our usual hospitality suite (room 2321), but everyone will have to go someplace else to eat. We will allow only 6 players in the suite at any one time. The suite will not be open for socializing at other times. We will have water, soft drinks, coffee and snacks in the Players' Break Room (1321), and there also, we will limit the number of people in the room at any one time. Eating in the Break Room is not allowed. Masks will be required in the hospitality suite and in the Players' Break Room.

6. There will be air purifiers in each playing room and in 1321 and 2321.

ROUND ROBIN KIBITZING ON REALBRIDGE KIBITZ SITE

To kibitz, go to **the RealBridge kibitzing website**, enter your name and click on Log In. That will take you to a screen where you can select the event to kibitz.

After you select Kibitz 2021 Mixed USBC, you will be taken to a lobby with a list of tables on the left and a chat box and list of people in the lobby on the right. The table listing reflects the team & players at the table + the board number and trick at that point. There is also information about the # of kibitzers and whether audio/video commentary is active (a picture of a TV means there is). Click table to kibitz. You will see a hand diagram with the bidding and play as it happened.

There is a chat window on the right of the screen. Anyone can type chat into the chat window.

Above the chat window are two dropdowns for video commentary. If you want to hear someone who is commenting, select their name from one of the dropdowns. If two people are commenting **one from each dropdown**. The option "BROADCAST MY VIDEO" is for commentators - if you select this, your commentary will be available to anyone who wants to listen to you.

KO KIBITZING ON LOVEBRIDGE

You can follow the USBC on the https://vugraph.lovebridge.com/ website. The stream is delayed; go to the schedule (Page 6) for starting times for each segment.

Popcorn time! Do you want to listen to commentary? Search for the TV icon! It will send you to the page where you can choose from the available live commentary. If it doesn't do anything, no one is commenting.

Nail biting! Do you want to be deeply involved? Choose the "Match view" at the starting page of your event. Your screen will be divided into four small screens – two of them showing the two tables of match you choose, the other two having the scoresheet for your match and the current scores of the other matches. In the 2x2 view you can also personalize the content in all your windows. (The 2x2 view is not available on mobiles.)

Think together! When watching a table, click on a name and choose "Kibitz". Instead of seeing all 4 hands, you will see what the player sees, and you can decide what you would do and see whether your chosen player agrees.

More Information: Be well informed and tell your friends: while following the play, you can click many items. The image of the sticker with the number of the board (upper right) takes you to the results of the board, in the bottom right corner the arrow takes you the scoresheet, the DDS shows the double dummy analyses, beside that there is a button for the other table of the same match, at the top left corner you can see the bidding with alerts and the explanations (mouse over), the tricks already played, and the double dummy analysis for the available number of tricks with the par score.

Navigation icons: while surfing here and there in the vugraph, or amongst the archive sessions, there are icons to help you. You can always go back to the main page with the "house" or to the standings with the "scores". If you cannot see the icons, move your mouse, or touch your screen and they pop up immediately. There is also a built-in back button because the back button of your browser will always take you to the starting page. If this is not what you wanted, push next in your browser and you can continue where you were.

Replay: After the event you can find every board from every table easily. While replaying the hands, the only surprise can be the way "next board" button works. If you have arrived from a scoresheet, it navigates through the scoresheet. If you have arrived from a screen where the results were shown for a given board then the same buttons move you through list. Push every button and enjoy!

Onion and Salami Sheet Pan Pizza

Ingredients

Ingredient Checklist

- 1/4 cup extra-virgin olive oil, plus more for drizzling
- 2 (1-pound) fresh prepared multigrain or plain pizza dough balls, at room temperature

- 🗖 4 ounces salami, soppressata, or spicy Italian sausage
- 🗖 2 ounces Parmesan or pecorino Romano cheese, grated (about 1/2 cup)
- 🗖 1/2 teaspoon fennel seeds, crushed
- 🗖 Flaky sea salt
- Fresh baby greens or herb leaves (such as flat-leaf parsley or basil)

Directions

Instructions Checklist

🗆 Step 1

Preheat oven to 500°F with oven rack in lower third of oven. Grease an 18- x 13-inch rimmed baking sheet with 1/4 cup oil; place 1 dough ball on 1 side. Using your hands, gently stretch outward into an even layer until it covers half of the baking sheet. (If dough springs back, let it rest for 10 minutes before stretching again.) Repeat procedure with remaining dough ball on opposite side of baking sheet. Press seam together in middle to seal, creating 1 large sheet of dough. Spoon pizza sauce evenly over dough; sprinkle with mozzarella, and top with salami, spring onion, Parmesan, and fennel seeds.

Bake in preheated oven until crisp and brown on bottom and edges, about 25 minutes. Remove from oven, and sprinkle with salt. Top with greens; drizzle lightly with additional oil.

Ingredients

- 2 1/4 cups gluten-free all-purpose flour
- 🗌 1/4 cup ground almond meal
- 🔲 3/4 cup freshly grated Parmigiano-Regiano cheese
- Kosher salt
- Pepper
- 1 1/4 cups warm water
- 2 teaspoons active dry yeast
- 1 teaspoon sugar
- Extra-virgin olive oil
- 📃 1 large egg, lightly beaten
- 9 ounces spicy Italian sausage, casings removed
- 🔲 3 ounces curly kale, stemmed and torn into bite-size pieces
- 📙 3/4 cup marinara sauce
- 8 ounces salted mozzarella, coarsely grated

Directions

- **Step 1** In a medium bowl, whisk the flour with the almond meal, 1/4 cup of the Parmigiano and 1 tablespoon of the salt.
- **Step 2** In a large bowl, combine the warm water with the yeast, sugar and 2 tablespoons of olive oil. Let stand until the yeast is foamy, about 5 minutes. Using a whisk, stir in the egg until just combined. Add the dry ingredients and, using a rubber spatula, stir until combined. (The dough will be wet, more like thick muffin batter.) Scrape the dough into a lightly oiled bowl and turn the dough to coat. Cover the bowl with plastic wrap and let rise in a warm, draft-free spot until doubled in bulk, about 1 hour.
- **Step 3** Generously brush a 9-by-13-inch baking pan with olive oil. Using a rubber spatula, scrape the dough into the prepared pan. Use lightly greased hands to pat the dough into an even layer and into the corners of the pan. Cover loosely with plastic wrap and let rise until doubled in bulk, about 1 hour more. Discard the plastic wrap.
- **Step 4** Preheat the oven to 450°. Bake the pizza crust for 20 minutes, until it is golden brown and springs back lightly to the touch. Transfer the crust to a wire rack.
- Step 5 Meanwhile, in a medium skillet, heat 1 teaspoon of oil over moderate heat until shimmering. Add the sausage and cook over moderate heat, breaking the meat into bite-sized chunks with a slotted spoon, about 6 minutes. Transfer the sausage to paper towels to drain; wipe out the skillet and return to the stove.
- **Step 6** In the same skillet, warm 1 teaspoon of olive oil until shimmering. Add the kale and generous pinches each of salt and pepper. Cook, stirring frequently, until barely tender, about 3 minutes. Remove the skillet from the heat.
- **Step 7** Spoon the marinara sauce over the crust, leaving a 3/4-inch border around the edges. Sprinkle the mozzarella over the sauce. Top the pizza with the sausage, kale and red onion and sprinkle with the remaining 1/4 cup of Parmigiano.
- **Step 8** Bake for 15 minutes until the cheese is bubbling and beginning to brown, rotating from front to back halfway through the baking time. Transfer to a wire rack and let stand for 10 minutes. Sprinkle with remaining 1/4 cup of Parmigiano and cut into squares.

- Step 2

In a bowl, toss the mesclun with the parsley, mint, pea shoots and lemon juice. Spread the hummus on the hot crust. Pile the salad on the pizza and season with flaky sea salt and pepper. Drizzle with olive oil and top with shredded ricotta salata. Cut into wedges and serve right away.


Three rounds of spades followed and declarer had to guess for the DQ.





Meet the Players...



Irina Solomonovna Levitina is a Russian-American chess and bridge player. In chess, Irina was a World Championship Candidate in 1984 and gained the title Woman Grandmaster. In contract bridge she has won five world championship events, four women's and two mixed titles, including play on two world-champion USA women teams.

In 1986, she took 7th in Malmö (Candidates Tournament; Elena Akhmilovskaya won). In 1987, she tied for 2nd–4th in Smederevska Palanka (interzonal). In 1988, she tied for 3rd–4th in Tsqaltubo (Candidates). In 1991, she tied for 3rd–4th in Subotica (interzonal). In 1992, she took 6th in Shanghai (Candidates; Susan Polgar won).

In 1982, she took 2nd in Tbilisi (interzonal). In 1983, she beat Nona Gaprindashvili 6 : 4 in Lvov (quarterfinal), and Alexandria 7,5 : 6,5 in Dubna (semifinal). In 1984, she beat Lidia Semenova 7 : 5 in Sochi (final) and became World Women's Championship Challenger. Levitina lost to Maia Chiburdanidze 5½ : 8½ in a title match at Volgograd 1984.

After her emigration in 1990 to the United States, she has also been U.S. Women's Champion in 1991 (jointly), 1992, and 1993 (jointly).

Levitina is now a professional bridge player. She has won 5 world champion titles in women's bridge and many "national" titles (major events at North American Bridge Championships, thrice-annual 10-day meets). Sometime prior to the 2014 European and World meets (summer and October), Levitina ranked 15th among 73 Women World Grand Masters by world masterpoints (MP) and 5th by placing points that do not decay over time.

She was the Soviet Women's Champion four times—in 1971, 1978 (jointly), 1979, and 1981, who was not allowed to play in the 1979 Women's Interzonal in Buenos Aires and for the World Women's Championship because her brother immigrated (legally) to Israel.










In the Hinze/Moss match, John Hurd made the magic bid of splintering 4D on the West hand. Wolpert bid 4S (RKC for hearts) and Hurd showed one keycard. Wolpert jumped to slam.

Enfield led the CA and shifted to the S5. Wolpert won the SA and cashed the CK, discarding her losing spade. Wolpert played a trump to the ace, cashed the DA and trumped a diamond to crossruff. Jenny led a small spade and Hinze played the SK. Wolpert ruffed and claimed twelve tricks.

At the other table Cappelletti/Howard stopped in 4H, also taking twelve tricks.

In the Hammond/Rubenstein match, Hammond opened 1D with the South hand. Wooldridge made a takeout double and Onsgard preempted 3D. Molson assumed her partner had a singleton diamond and useful values for his vulnerable takeout double. Backing up her assumption, she jumped to 6H.

Hammond led the CA and switched to the DK. Molson won and trumped a diamond. She led a trump to the ace and trumped another diamond. Molson cashed dummy's CK and SA, trumped a spade and trumped her last diamond in dummy to take twelve tricks.

At the other table Chang/Gettleman stopped in 4H making six.

In the Kolesnik/Lewis match, the Woolseys decided to get in the way of their opponents.

Kit opened 1D (11-15, could be a doubleton) on the South hand. His 2NT rebid was a minor suit takeout.

Sally knew they had a double fit and competed with 4D. At favorable vulnerability, Kit sacrificed in 5D.

Kamenova doubled.

The defense started with two rounds of hearts. Kit trumped and played the DK, which held the trick. He led the ST covered by the queen and king, and played the C2 to the ace and a club toward the queen. Kamenova won the CK and played the CJ.

Bidding a grand slam that depends on a two-way finesse for a queen is an aggressive tactic. Sometimes it is not obvious that a finesse will be needed.

On this hand, North and South had matching singletons. If North held two clubs and two diamonds, the grand would be a better proposition. Eight pairs bid the grand slam and three pairs stopped at the six level. All three small slam declarers won the opening heart or club lead, drew two rounds of trump and followed with the DK. They took the losing diamond finesse.

Watson lost 11 IMPs when the grand was bid at the other table and Rubenstein won 11 IMPs when their opponents stopped in 4S at the other table. Donner was the big winner. His opponents bid the grand and mis-guessed the DQ. 14 Imps to Donner

All but one of the 7H declarers played with the odds and made their grand slam. These declarers won the opening lead, drew trumps and played three rounds of spades before tackling the diamond suit. When West showed out on the third round of spades, West was known to hold nine cards in the minors. Unless they had passed throughout with a good seven-card club suit, West would have longer diamonds than East. The winning declarers cashed the DA and correctly finessed West for the DQ, scoring +1510 ... Jacobs, in 7H, took the same line as did the declarers in 6H. Taking the diamond finesse before getting the inferential count was safe in the small slam, but dangerous in the grand!
