I. CALL TO ORDER

The meeting was called to order by Jan Martel; president at 8:05pm

II. ATTENDANCE: ESTABLISH QUORUM

USA 1 finished 5th, USA 2 finished 18th. Shawn Quinn reported that the players all had a great time, behaved well . Shawn Quinn and Justin Lall did a great job as NPCs
